1. Ministry of Trade, Tourism, and Telecommunications, Nemanjina 22-26, Belgrade, www.mtt.gov.rs, a state administration body, is inviting all interested entities to submit their bids under the requirements from the tender documentation for public procurement.

Subject of the public procurement is – Procurement of the information and communication infrastructure for educational institutions (by lots).

The procurement is organised in lots.

Lot 1- Improvement of transport network on AMRES spine

Lot 2- Construction of wireless local computer networks in schools

Subject of the public procurement is the service and is in more details defined in the tender documentation.

2. Criteria for selection and granting the contract for Lot 1:

Criteria for granting the contract are economically most advantageous bid.

Weighting:

Minimal price – maximum 70 weights (Ap)

Methodology for weight award:

Number of weights – Ap is calculated by the following formula:

Minimal price offered by a bidder x maximal number of weights (70)

Ap = -----
Offered price from the bid of the bidder evaluated and ranked

If the bid meets the optional requirements from chapter 4 of technical specifications:

- (4.1) Offered equipment on locations Belgrade IF, Kragujevac, Niš, Sofia should have the ability of flexible switch of client FE/GE/STM-1/STM-4/STM-16/STM-64/10GE LAN/10GE WAN and FC100/200/400/800/1200/ESCON/40GE services in one wave length of capacity 100G directly, without cascade connection of transponder. 5 weights
- (4.2) Offered devices on every location contain universal client service card (any service card) which at the same time supports the flow from 10Gbit/s for access STM64, 10GE WAN, 10GE LAN, FC800/1200, OTU2, signals. Bidder shall be obliged to offer the relevant universal client service card in its bid -5 weights
- (4.3) Offered devices on every location contain OSA (Optical Spectral Analyser) unit (card) for monitoring the wavelength 10 weights
- (4.4) Offered monitoring and management system supports the future upgrade for managing Microwave, GPON and xDSL systems. -10 weights.

Note: Contract shall be granted to the bidder reaching the largest number of weights by adding the weights achieved based on the elements of the criterion of the minimal offered price (Ap) and the number of weights achieved depending on whether the offered solution meets the requirements of the items above (4.1), (4.2), (4.3) and (4.4). Formula Ap+(4.1) + (4.2) + (4.3) + (4.4)

If two or more bidders reach the same number of weights in the manner defined in the tender documentation the Contracting Party shall conduct drawing of lots, in line with Article 84 of the PPL, drawing the names of selected bidder from a box.

3. Criteria for selection and granting of contract for Lot 2:

Selection of the most advantageous bid will be based on the criterion of the "minimal offered price".

If two or more bidders reach the same total offered price the Contracting Party shall conduct drawing of lots, in line with Article 84, paragraph 4 of the PPL, drawing the names of selected bidder from a box.

4. Manner of taking over the tender documentation:

5. Manner of submitting bids and deadlines:

Deadline for submission of bids for Lot 1- Improvement of transport network on AMRES spine is 29/05/2018 before 10:00 o'clock at the clerk's office of the Contracting Party.

Deadline for submission of bids for <u>Lot 2- Construction of wireless local computer</u> networks in schools is 29/05/2018 before 10:00 o'clock at the clerk's office of the Contracting Party.

Work of the clerk's office for the Contracting Party shall perform the clerk's office of the Administration for Joint Activities of national bodies, Nemanjina 22-26, Belgrade. Detailed instructions about the manner of submission of bids are provided in the tender documentation for the mentioned public procurement.

5. Time and place of bids opening:

Bids opening for <u>Lot 1</u> – shall be held **on the same day** after the expiry of the deadline for bids submission, at 11:00 o'clock on the premises of the Contracting Party, Nemanjina 22-26, 10^{th} floor, office number 30. Bids opening is public.

Bids opening for $\underline{\text{Lot 2}}$ – shall be held on **the same day** after the expiry of the deadline for bids submission, at **12:30** o'clock on the premises of the Contracting Party, Nemanjina 22-26, 10^{th} floor, office number 30. Bids opening is public.

7. Requirements under which the bidder's representatives can participate in the bids opening:

Bidders' representatives participating in the public opening of bids on the behalf of the bidders must provide the Committee of the Contracting Party with the relevant authorisation, for both lots if bids are submitted for both lots, signed by the authorised person of the bidder with the seal of the bidder. Otherwise they attend the opening as the audience and cannot take an active role in the procedure (signing of the minutes, making an objection, etc.)

8. Deadline for decision making:

Deadline for decision making on granting the contract or cancelling the procedure is 25 days from the day of the bids opening, except in special cases, such as large or complex bids, when the deadline can be 40 days from the day of the bids opening, in line with Article 108, paragraph 2 of PPL.
